1. Executive Functions and Responsibilities:

The functions and responsibilities of Executive Director shall be in accordance with Nepal Agricultural Research Council Act, 2048 (with amendments) and its accompanying regulations, serving as the primary administrative and research authority of this esteemed national institution.

2. Candidate Eligibility Requirements:

Qualified applicants must fulfill the following professional criteria:

- Possess a minimum of a Master's Degree in a relevant discipline of agricultural and allied sciences from an academic institution formally recognized by the Government of Nepal.
- Currently hold the position of Senior Scientist (designated as S3 or above position) within any agricultural and allied science division under the purview of NARC.
- Demonstrate a distinguished career trajectory with a minimum of ten (10) years of substantive experience in agricultural research.
- Proof of research publications in agriculture and allied sciences.

3. Application Package Requirements:

Applicants must submit the following documents in a sealed and signed envelope:

- **Completed Application Form:** Clearly filled out with all required information.
- **Business Plan (Two sets of hard copies):**
 - A comprehensive Strategic Vision and Business Plan (maximum 5,000 words) presenting original, innovative, and realistic (farmer friendly) strategies for transforming NARC into an excellent agricultural, livestock and fisheries research organization.
 - Should demonstrate how NARC will contribute to the national vision of "Food Security, commercialization and sustainable agriculture".

- Must address, but is not limited to Agricultural research in Nepal: current status and future scenarios (including pandemic impacts, climate change, federalism and natural resource utilization).
- SWOT analysis of NARC.
- Collaboration with national/international agriculture research institution.
- Key problems/challenges in NARC's agricultural research and proposed solutions.
- **Research Publications:** Self-attested copies of scientific research publications related to agricultural or allied sciences.
- **Academic Credentials:** Self-attested copies of all academic qualifications mentioned in CV.
- **Employment Verification:** Official proof of employment at NARC including service period, position and class endorsed by NARC.
- **Electronic Presentation:** Time duration of PowerPoint presentation based on Strategic vision and Business Plan will be maximum 20 minutes.
- Date and venue of Presentation will be informed later.
- Applicants must submit their presentation on a pen drive to the Board/Corporation Desk one hour before their presentation scheduled time.

4. Application Submission Instructions

- **Document Organization:**

 - Hard copies (two sets) and a pen drive (containing electronic copies) of Strategic Vision and Business Plan (clearly labeled).
 - Publications (clearly labeled).
 - Remaining documents (clearly labeled).

6. Certificate Requirements:

- Equivalence certificates for degrees from foreign academic institutions must be submitted along with application.
- Candidates who have completed their study from Nepalese universities but have not received the original transcript and certificate should submit provisional certificates and mark sheets/transcript along with application.
- Documents received after the deadline will not be entertained.
